

## 2024 Fall Exchange Student Nomination

Hanyang University is happy to inform you that we begin accepting your nominations for 2024 Fall semester. This instruction only applies to 2024 Fall nominations as we are not yet ready to receive nominations for future semesters. Also the nomination is not needed for a student currently studying at Hanyang who wishes to extend their stay for another term. There is a separate process for study period extension and we will share the instruction upon request. ***Please note that students who have cancelled for 2024 Spring but wish to participate in 2024 Fall MUST be re-nominated through the system.***

### Nomination Period

April 1<sup>st</sup> (Monday) 00:00 – April 15<sup>th</sup> (Monday) 23:59 KST

### Nomination Method

- Online Nomination must be submitted through the system. (Instruction Attached)
- Nomination must be completed by a home university coordinator for each student planning to enroll at Hanyang University as an exchange student.
- **E-mail nomination will NOT be accepted** so please make sure your students are nominated through our system even if you have sent us an email previously.
- **Please complete the nomination by the deadline above as late nomination will not be considered**

### Nomination Details

<b>Qualification</b>	<p>Students must satisfy all qualification below to be accepted as an exchange student at Hanyang. <b>Nominees who fail to meet the requirements will not receive an application email from us.</b></p> <ul style="list-style-type: none"> <li>• <b>No. of semester completed:</b> At least one semester completed by the time of nomination and must be able to provide an official transcript with final score</li> <li>• <b>Cumulative GPA:</b> 60% or higher based on the grading system at student's home university. Home University's grading system will take precedence over any conversion tables submitted.</li> <li>• <b>Language Proficiency: Qualified level of English or Korean (Please refer to the information sheet for details)</b></li> </ul>
<b>Additional Information</b>	<p>The nomination details must match with the details of the student's application. In case the application details need editing, the nomination details must be edited by the home university and the changes will be reflected on the application page accordingly. Therefore, <b>please make sure to consult with your student(s) for their study plan before nominating them.</b> If needed, you may share a copy of your nomination with students so that s/he can check the details of nomination before filling out the application.</p>

Every semester, we try our best to help students to complete the course registration with their desired courses. However, as **the course registration system works on first-come-first-served basis, their preferred choices of courses are NOT GUARANTEED. So we ask exchange students to be flexible with their course preferences.**
